## What is the Awareness Pack?

As part of the statutory safeguarding partners commitment to support the effective implementation of our revised local threshold document, Framework for Action (FFA) and the Integrated Front Door (IFD), we have developed a single agency awareness pack.

The pack contains a slide deck and activities to help individual organisations to fully integrate these safeguarding arrangements into their processes and practice. All practitioners working with children, their parents and carers should have a good understanding of these arrangements and be able to apply them consistently, from prevention to protection, to keep children in Bolton safe.

The aim of the resource is to: -

- Identify, assess and respond to children and their families needs at the earliest opportunities using thresholds to guide action
- Help children and their families access additional help and support when needed
- Know when, how and where to access advice and guidance about thresholds and interventions
- Know when and how to resolve professional differences and escalate concerns using local processes

### How and when should I use the Awareness Pack?

The awareness pack is one element of a suite of resources the partners have made available, the others are: -

- Framework for Action Threshold Document
- Launch Event Webinar
- FFA and IFD Briefing Webinars
- FFA and IFD Frequently Asked Questions
- Knowledge Nugget

It is the responsibility of individual organisations to determine how they will deliver and track use of the awareness pack in their services and settings. The statutory safeguarding partners believe it could be used, as a minimum, within: -

- Induction Processes
- Strategic Service Development Days
- Team Meetings
- Inset Training

As part of their scrutiny and quality assurance function, the statutory safeguarding partners will review usage and impact in six months of this resource being launched. Therefore organisations are encouraged to keep a record of the action they have taken to embed the FFA and IFD arrangements and the effectiveness of the partner's resources in supporting them.
